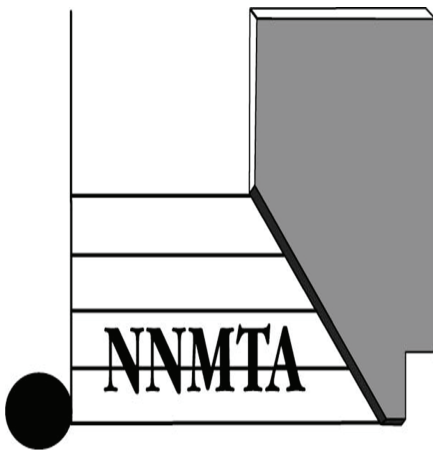

NNMTA Update

Hello from up north! It has been a productive few months. Beginning with the fi-

nancial report, UNR has billed us for the March festival at UNR last year as well as the MusikFest in November 2007, so that leaves us with \$5,299.83 in the checking account. Our other two savings accounts have \$1,459.38 and \$1,893.63.

The Special Events and Promotion Chair that I created at the end of last year has been filled. Thank you to Kathryn Mickey and Margarita Bryant for co-chairing this position. I created the position with the philosophy that any amount of promotion of our events is better than none at all. They will be focusing on promoting any events which are of public interest, such as student command performances, convention recitals, master classes, and teacher recitals. They will also act as organizers and coordinators for events such as master classes, workshops and recitals.

Christine Barden, our Membership Chair, has been fulfilling her position's newly-defined duties of recruitment and mentorship of new teachers very well – we already have a new member resulting from her efforts! Way to go Christine!

Our two festivals this year are approaching. Lower levels go in May, and Upper levels are coming up in March. This switch was made because May is the worst month of the entire year for high school students to have their "big" performance each year since that is also when AP exams take place, projects are due, and final exams approach. The NNMTA brainstormed and discussed extensively any possible factors that might render this date switching more damaging than relieving, and we concluded the only way to really know with any amount of certainty was to try it. We knew going into it that we would have less participation since upper level students would only have 10 months to pre-

pare instead of 12. It's starting to look like it will be about 60% participation compared to previous years. The upper festival has already run "in the red" every year since judge and trophy costs always outweigh student registration fees, so we're in for quite a cost this year. Fortunately, this will offset by the fact that the upper level festival did not even take place last year since nobody was available to run it – we will be no worse off than if we had run a "normal" upper festival both years.

The NNMTA is now utilizing Yahoo Groups to facilitate communication between members and sharing of documents. It is working out beautifully. Members communicate with each other instantly by sending e-mail to nnmta@yahoogroups.com. PDF files can be uploaded to the files section, and an e-mail is automatically sent to the entire group with a convenient download link. Calendar dates can be set up with up to 2 reminders to automatically be sent to members, reminding them of registration deadlines, recitals, and other important dates as they approach. We also are using Yahoo Groups for the NNMTA Board (nnmtaboard@yahoogroups.com). We have already utilized the polling feature to take votes on motions. Once a poll is concluded, the results are automatically e-mailed to the entire group.

The online registration deadline will be announced in the Guidelines, as well as a few changes regarding mostly time limits and accompanist fees. **Please also note that the piano concerto requirement for the Senior and Young Artist levels has been discontinued.**

TO: State Presidents and all competition officials
FROM: Linda Stump, MTNA Director of Competitions

The following changes have been made in the competition guidelines for the 2009-2010 competition year. The Board of Directors approved these changes at their December, 2008, meeting.

Since some of the changes are quite substantial, we would like for state presidents and competition officials to pass this information along to all teachers.

2009-2010 Competition Changes:

1. Junior Brass competition has been discontinued.
2. **The piano concerto requirement for the Senior and Young Artist levels has been discontinued.**
3. The performance times have been modified to fit the performance requirements:
 - a. **Junior:** all students will have twenty (20) minutes of performance time.
 - b. **Senior:**
State level: twenty-five (25) minutes for brass, piano, piano duet, string, woodwind. Voice will have twenty (20) minutes.
Division/national levels: thirty (30) minutes for brass, piano, piano duet, string, woodwind. Voice will have twenty (20) minutes.
 - c. **Young Artist:**
State level: thirty (30) minutes for all categories.
Division/national levels: forty (40) minutes for brass, piano, string, woodwind.
Voice will have thirty-five (35) minutes.
 - d. **Chamber Music:**
State level: thirty (30) minutes
Division/national levels: forty (40) minutes
4. Accompanist fees have also been adjusted:
Junior: \$80 for forty-five (45) minutes rehearsal and performance (no change)
Senior Instrumental: \$150 for sixty (60) minutes rehearsal and performance
Senior Voice: \$90 for forty (40) minutes rehearsal and performance
Young Artist Instrumental: \$175 for sixty (60) minutes rehearsal and performance
Young Artist Instrumental: \$200 for ninety (90) minutes rehearsal and performance
Young Artist Voice: \$175 for sixty (60) minutes rehearsal and performance
